WILLIS E. BRIDEGAM, JR., formerly director of libraries at the State University of New York at Binghamton, has been named librarian of

Amherst College. Amherst President John William Ward announced the appointment, which became effective August 1, 1975, after an extended search by a committee consisting of members of the college's faculty and administration.

At Binghamton since 1972, Mr. Bridegam was responsible for all library services

—including the main, science, music, and three undergraduate libraries. During the preceding ten years, he was associated in a wide range of capacities with the Rush Rhees Library and the Edward G. Miner Medical Library at the University of Rochester, where he was also associate professor of bibliography.

Mr. Bridegam prepared for college at the Hill School in Pottstown, Pa., and earned a bachelor of music degree at the Eastman School of Music of the University of Rochester in 1957. Though his interest in music continued, he soon became involved in library activities and earned his master of science in library science degree at Syracuse University in 1964.

He has served on many national and New York State committees and as an officer of several professional organizations, including the American Library Association, the New York Library Association, and the South Central Research Library Council. In 1973 he was chairman of the Chancellor's *ad hoc* Committee on Open Access in the State of New York Libraries. At Binghamton he has been a member of the university's major committees and continues his interest in music as a member of the Binghamton Symphony and Choral Society Board of Directors.

Amherst's Robert Frost Library, which was completed in 1965, has a collection of nearly 500,000 volumes. Since 1970, Professor Richard J. Cody, a member of the English department, has served as college librarian, and Dr. Charles T. Laughler has served as director of the Robert Frost Library. Mr. Bridegam will combine the two responsibilities.


