**Frances Maloy**, leader of the access services division at Emory University General Libraries, is the 67th president of ACRL.

"It has been an honor to serve you as vice president/president elect of ACRL. As I work with my Appointments Committee to complete the slate of officers for the coming year, I am reminded of how fortunate we are to have such talented and hard-working staff and member volunteers leading the work of ACRL.

"I am also inspired by the ACRL Board who are knowledgeable about issues, concerned about the needs of members, and giving of their time and talent. The Board has been working very hard to bring you a completed strategic plan by the 2004 ALA Annual Conference. The plan is based upon member input that was gathered from surveys, focus groups, telephone calls, and face-to-face conversations about the future of academic and research libraries and higher education. It also focuses on how ACRL can continue to provide vital support to librarians.

"During my year as president, I will be leading the association in developing action plans and implementing some of the new initiatives outlined in the strategic plan. I will also be leading efforts to align ACRL's organizational structure with the work of the association.

"I am also very excited about my theme, 'Libraries are Education: Original Thinking About Our Core Purpose,' which will guide my President's Program Planning Committee in their work and be the focus of a series of articles in *C&RL News*.

"Thank you for all of your support, continued hard work, and commitment to academic and research libraries, as well as to ACRL."

As president, Maloy will preside over the ACRL Board of Directors and ACRL Executive Committee, chair the ACRL Conference Program Planning Committee for the 2005 Annual Conference, and plan ACRL's major program at the conference. She will work with the ALA president and other division presidents representing ACRL both within and outside of ALA.

From 1999 to 2001, Maloy was leader of organization redesign at Emory. In addition, she held the position of head of the circulation department from 1992 to 2001. At Hamilton College, she was director of public services (1983–92) and assistant reference librarian (1982–83).

Her activities in ALA divisions include service on the ACRL 2002 Nominations Committee, of which she was chair (2000–01). Maloy also served as chair of ACRL's Committee on Ethics (2000–03) and was

the ACRL liaison to the ALA Committee on Professional Ethics (1997–03). She has also served as a member of the Board of Directors for the Supplemental Funding Task Force (2000–02) and on the Conference Program Planning Committee, Washington, D.C. (1998). Maloy has also been active on the LAMA/LOMS Planning and Evaluation of Library Services Committee (1992–93).

In state and regional associations, Maloy was a member of the University Center of Atlanta, Georgia Consortium: Interlibrary Use Committee (1992–01), a member of the Direct Borrowing Task Force (1992–96), and secretary of the Central New York Resource Council's Professional Development Committee (1982–87). She was also a member of the automation planning committee (1985).

In addition, Maloy has been a member of the Organizational Change Alliance since 1994.

Her publications include "Defending the freedom to read: A reflection of personal values and censorship," *C&RL News* (March 1998).

Maloy received her bachelor of arts degree from St. Lawrence University and her MLS from the State University of New York at Albany.

**Camila Alire**, dean of library services at the University of New Mexico, has been elected vice president/president elect of ACRL.

Among her ALA activities are service on ALA Council (1997–03); Executive Board (2000–03); Finance and Audit Committee (2000–03); American Libraries, chair (1997–99); Executive Director Search Committee, chair (1997–98); Education Committee, chair (1996); Nominating Committee, chair (1995); Accreditation Site Visitation Teams, (1989, 1991, 1994, 2000).

Alire's activities in REFORMA include the Executive Board (1987, 1989–95, 1999–00); the Education Committee, chair (1999–00); the National Conference Steering Committee, fundraising chair (1995–97); the National President (1993–94); and the Finance Committee, chair (1994–95).

Alire was awarded the ALA Elizabeth Futas Catalyst for Change Award (1997), the Mountain Plains Library Association Legislative Leadership Award, and the CLA Exemplary Library Services to Ethnic Populations Award (1995 and 1998).

Her publications include *Library Disaster Planning and Recovery Handbook*, editor/contributor, 2000; *Serving Latino Communities*, co-author, 1998; "Minorities and the Symbolic Potential of the Academic Library," co-author, *College and Research Libraries*, November 1995.

Alire received her bachelor of arts degree from Adams State College and her MLS from the University of Denver. She also received her doctorate in higher education administration from the University of Northern Colorado.
